

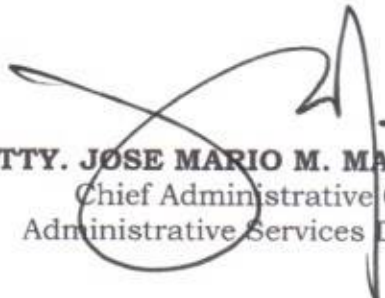

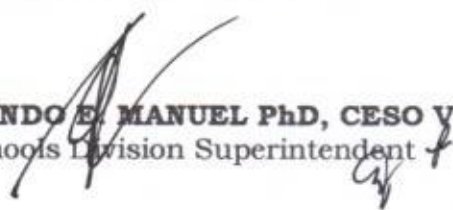

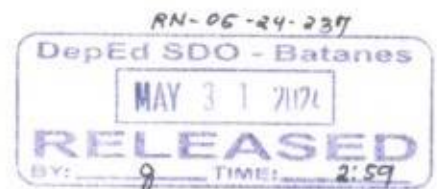

My warmest MATATAG Greetings!

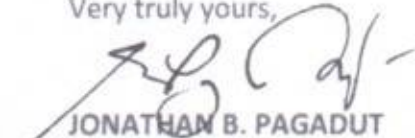
