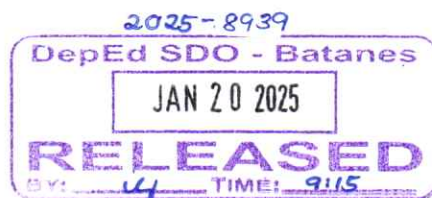
5. All ALS teachers involved during the conduct of the A & E test shall be entitled to one day Compensatory Time Off since scheduled test falls on a Sunday.
